RE: **STAFF UPDATE** – IN THE MATTER OF THE APPLICATION OF ZEUS TELECOMMUNICATIONS, L.L.C. FOR APPROVAL OF A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE RESOLD LONG DISTANCE TELECOMMUNICAITONS SERVICES (DOCKET NO. T-20479A-06-0585)

On September 18, 2006, Zeus Telecommunications, LLC, (“Zeus” or “Applicant”) filed an Application with the Arizona Corporation Commission (“Commission”) for a Certificate of Convenience and Necessity to provide competitive resold long distance telecommunications services within the State of Arizona. On June 16, 2008, the Administrative Law Judge issued a Procedural Order which stated that Staff shall file an update on Zeus’s Application along with any appropriate recommendations no later than August 18, 2008. On August 12, 2008, Staff filed an update recommending that the docket remain open as requested by the Applicant as the Applicant would be responding shortly to Staff’s First Set of Data Requests. On January 6, 2010, the Administrative Law Judge issued a Procedural Order ordering Staff to file an update on Zeus’s Application along with any appropriate recommendations no later than February 15, 2010.

On January 20, 2010, Staff emailed Becky Heggelund, an assistant at Zeus’s attorney’s office, for an update on the Application as nothing new had been filed from Zeus in the Docket. Ms. Heggelund replied that same day and indicated that she would investigate the matter and contact Staff promptly. On February 1, 2010, Staff sent a follow-up email to Ms. Heggelund and on February 8, 2010, left a telephone voice message for Ms. Heggelund. Staff has not received a response to either follow-up attempt.

Given that the Applicant has not responded to Staff’s First Set of Data Requests and the length of time that has elapsed since the Application was originally submitted, Staff recommends that this Docket be administratively closed.
