## SAGUARO TO NORTHLOOP TRIP ITINERARY

▶ *denotes stopping/viewing site*

Start: Omni Tucson National at 8:30 a.m. October 7, 2009

Head west on Club Drive to Shannon

Turn South (left) on Shannon to Cortaro Farms Road

Turn West (right) on Cortaro Farms Road

Proceed approximately 3.4 miles west to Interstate 10 (I-10), head north (right) on I-10 approximately 6.2 miles to Tangerine Road exit.

Head east on Tangerine road (approximately 2.5 miles)

Head south on access road under existing line approximately 1.2 miles to North Loop boundary fence

▶ Stop at North Loop fence and point out southern end of alignment and entry into North Loop

Return to Tangerine

▶ Stop and look at existing lines at Tangerine, explain where and how new line would cross Tangerine

Cross Tangerine road and head north on access road under existing line approximately .5 miles to turning point.

▶ Stop and review existing line to northwest and to south, explain proposed construction

Return to Tangerine road

Turn west (right) on Tangerine and proceed approximately 2.4 miles to I-10 frontage road

Turn north (right) onto I-10 and proceed for approximately 4 miles to the Marana road exit 236,

Turn East (right) on W Coachie Canyon Trail, travel approximately 1.4 miles across CAP canal

▶ CAP alignment, will show where CAP option is

Continue east along W Coachie Canyon Trail approximately 0.9 miles to existing TEP corridor

▶ View proposed alignment along existing corridor to north and south, also location of Adonis Substation

Return to I-10 frontage road and head north (right) on frontage road approximately 8 miles to Saguaro

Substation road to the east

Turn east (right) on Saguaro access road

After crossing RR track turn south on access road to Tortolita, travel approximately 0.2 miles to clearing

▶ point out connection point for SWTC 115kV line into Saguaro as well as existing 138kV line (segment 1) to be rebuilt as part of project

Continue approximately 1 mile to Tortolita Substation

▶ point out where the new transmission line from Tortolita to Northloop (segment 2) would begin

Return to I-10 frontage road north (right) proceed approximately 1.8 miles to Sasco overpass (Red Rock
