PROCEDURAL ORDER

11 **BY THE COMMISSION:**

13 On August 31, 2009, Bella Vista Water Co., Inc. ("BVWC") filed with the Arizona
14 Corporation Commission ("Commission") an application for an increase in its rates.

15 The same date Northern Sunrise Water Company Inc. ("NSWC") and Southern Sunrise Water
16 Company ("SSWC") also filed rate applications in Docket Nos. W-20453A-09-0412 and W-20454A-
17 09-0413, respectively.

18 On August 31, 2009, BVWC, NSWC and SSWC (collectively the "Applicants") filed a Joint
19 Application for Approval of Authority to Transfer Utility Assets from NSWC and SSWC to BVWC,
20 pursuant to A.R.S. § 40-285 ("Joint Application").¹

21 On September 1, 2009, in the above-captioned rate application docket, BVWC filed a Motion
22 to Consolidate the rate applications of the three companies and the Joint Application.

23 On September 30, 2009, the Commission's Utilities Division ("Staff") notified the Applicants
24 that their rate applications were sufficient.

25 The determination of whether to consolidate the dockets will affect the procedures for
26 processing the various dockets.

27 IT IS THEREFORE ORDERED that a **telephonic Procedural Conference** for the purpose of



1 discussing the requested consolidation of the dockets and a schedule shall commence on **October 23,**
2 **2009, at 10:30 a.m.** at the Commission's Tucson offices, Room 218, 400 West Congress, Tucson,
3 Arizona 85701.² To participate telephonically, parties should contact the Hearing Division (602)
4 542-4250 prior to the Procedural Conference.

5 IT IS FURTHER ORDERED that **Staff shall file a Response to the Motion to Consolidate**
6 **by October 19, 2009.**

7 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
8 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


