PROCEDURAL ORDER

BY THE COMMISSION:

On August 31, 2009, Southern Sunrise Water Company Inc. ("SSWC") filed with the Arizona Corporation Commission ("Commission") an application for an increase in its rates.

The same date Bella Vista Water Co., Inc. ("BVWC") and Northern Sunrise Water Company Inc. ("NSWC") also filed rate applications in Docket Nos. W-02465A-09-0411 and W-20454A-09-0412, respectively.

On August 31, 2009, BVWC, NSWC and SSWC (collectively the "Applicants") filed a Joint Application for Approval of Authority to Transfer Utility Assets from NSWC and SSWC to BVWC", pursuant to A.R.S. § 40-285 (the "Joint Application").¹

On September 1, 2009, in the above-captioned rate application docket, SSWC filed a Motion to Consolidate the rate applications of the three companies and the Joint Application.

On September 30, 2009, the Commission's Utilities Division ("Staff") notified the Applicants that their rate applications were sufficient.

The determination of whether to consolidate these dockets will affect the procedures for processing the various dockets.



5 542-4250 prior to the Procedural Conference.

6 IT IS FURTHER ORDERED that **Staff shall file a Response to the Motion to Consolidate**
7 **by October 19, 2009.**

8 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
9 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


