BY THE COMMISSION:

On May 20, 2009, Bellemont Water Company, Inc. ("Company" or "Applicant") filed with the Arizona Corporation Commission ("Commission") an application seeking authorization to incur \$1,750,000 in long-term debt from the Water Infrastructure Finance Authority of Arizona in Docket No. W-02526A-09-0253.

On September 3, 2009, the Company filed with the Commission an application seeking Commission approval of a permanent rate increase in Docket No. W-02526A-09-0421.

On October 15, 2009, the Commission's Utilities Division Staff ("Staff") filed a Motion to Consolidate the above-referenced dockets. Staff believes that consolidation of these dockets would provide a more efficient use of Commission resources.

Accordingly, these dockets should be consolidated.
