PROCEDURAL ORDER

BY THE COMMISSION:

On August 31, 2009, Bella Vista Water Company ("BVWC"), Northern Sunrise Water Company, Inc., ("NSWC") and Southern Sunrise Water Company, Inc. ("SSWC") filed a Joint Application for Approval of Authority to Transfer Utility Assets from NSWC and SSWC to BVWC (collectively the "Applicants"), pursuant to A.R.S. § 40-285.

On September 1, 2009, the Applicants filed a Motion to Consolidate the above-captioned Joint Application with the rate applications filed by BVWC in Docket No. W-02465A-09-0411, NSWC in Docket No. W-20453A-09-0412 and SSWC in Docket No. W-20454A-09-0413.


By Procedural Order dated October 5, 2009, a telephonic Procedural Conference was set to commence at 10:30 a.m. at the Commission's Tucson Office. 
