PROCEDURAL ORDER

BY THE COMMISSION:

On August 31, 2009, Southern Sunrise Water Company Inc. ("SSWC") filed with the Arizona Corporation Commission ("Commission") an application for an increase in its rates.

The same date Bella Vista Water Co., Inc. ("BVWC") and Northern Sunrise Water Company Inc. ("NSWC") also filed rate applications in Docket Nos. W-02465A-09-0411 and W-20454A-09-0412, respectively.

On August 31, 2009, BVWC, NSWC and SSWC (collectively the "Applicants") filed a Joint Application for Approval of Authority to Transfer Utility Assets from NSWC and SSWC to BVWC", pursuant to A.R.S. § 40-285 (the "Joint Application").¹

On September 1, 2009, in the above-captioned rate application docket, SSWC filed a Motion to Consolidate the rate applications of the three companies and the Joint Application.

By Procedural Order dated October 5, 2009, a telephonic Procedural Conference was set to commence at 10:30 a.m. at the Commission's Tucson Office. Because subsequent events require the presiding Administrative Law Judge to be in Phoenix for another hearing on October 23, 2009, the location of the Procedural Conference in this matter will be moved to the Phoenix office. Parties may



7 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
8 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
