 15 On March 13, 2009, Litchfield Park Service Company ("LPSCO") filed an application before  
 16 the Arizona Corporation Commission ("Commission") requesting authority to issue evidence of  
 17 indebtedness in an amount no to exceed \$1,755,000 in Docket No. W-01427A-09-0116.

18 On the same day, LPSCO also filed before the Commission an application before the  
 19 Commission requesting authority to incur evidence of indebtedness in an amount not to exceed  
 20 \$1,170,000 in Docket No. W-01427A-09-0120.

21 Staff has reviewed the applications and it is Staff's opinion that since the two applications  
 22 will of necessity impact one another, it would be appropriate to process them in within a single  
 23 docket.

24 Staff also believes that consolidating the two dockets will conserve Commission resources.
