**STAFF'S RESPONSE TO RUCO'S MOTION
TO EXTEND THE TIME TO FILE ITS
DIRECT REQUIRED REVENUE AND RATE
DESIGN TESTIMONY**

The Utilities Division of Arizona Corporation Commission ("Staff") hereby responds to the Residential Utility Consumer Office's ("RUCO") Motion to Extend the Time to File Its Direct Required Revenue and Rate Design Testimony ("Motion"). As indicated in RUCO's Motion, Staff does not object the changes requested by RUCO. However it is unclear from RUCO's motion whether it is seeking only to change the filing deadlines for its direct testimony regarding revenue requirement and rate design or whether it is seeking to change those deadlines for Staff and the other intervenors. While Staff does not object to RUCO's request, these new deadlines should apply to Staff and any other intervenors.

Wherefore Staff respectfully requests that if the Administrative Law Judge is inclined to grant RUCO's request that the proposed changes in the schedule also apply to Staff and any other intervenors.
