On September 18, 2009, Sulphur Springs Valley Electric Cooperative, Inc. ("SSVEC") filed an Application to implement a moratorium on new and expanded service connections that would be serviced by the existing V-7 Feeder Line within the areas of whetstone Rant, Rain Valley, Elgin, Canelo, Sonoita and Patagonia ("Affected Areas").

On October 9, 2009, Susan J. Downing, a Santa Cruz County SSVEC customer, filed a Motion to Intevene.
