PROCEDURAL ORDER

BY THE COMMISSION:

On May 1, 2000, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing Regarding Proposed Order for Relief ("Notice") against Scott A. Gould ("Respondent") in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in Connection with the offer and sale of securities in the form of promissory notes and violations of Commission Orders in Decision No. 59055 (April 5, 1995).

The Respondent was duly served with a copy of the Notice.

On May 15, 2000, Respondent Scott A. Gould filed a responsive pleading which did not request a hearing. Thereafter, the Division prepared a Default Order for consideration by the Commission at its September 12, 2000, Open Meeting.

On September 12, 2000, Mr. Gould appeared and made it known that he wanted a hearing and the Commission referred the matter to the Hearing Division.

Accordingly, a pre-hearing conference should be scheduled to address the issues raised in the Notice, the disclosure of witnesses to be called and the presentation of evidence.


