PROCEDURAL ORDER

BY THE COMMISSION:

On July 15, 1998, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Temporary Order to Cease and Desist and Notice of Opportunity for Hearing ("Notice"), naming Respondents Robert J. Stahl, Elizabeth Boyd, and David V. Francis.

On August 7, 1998, pursuant to the Notice, Respondent Stahl filed with the Commission a request for a hearing pursuant to A.R.S. §§44-1971 and 1972, and requested that the hearing be set for not less than thirty days from the request.

IT IS THEREFORE ORDERED that the hearing as to the allegations against Respondent Stahl shall be consolidated with the hearing scheduled for Respondent Boyd in the above-captioned matter and shall commence on **September 23, 1998 at 9:30 a.m.**, or as soon thereafter as is practical, at the offices of the Arizona Corporation Commission, 1200 West Washington Street, Phoenix, Arizona 85007.
