Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT



- 1. Phonetel Technologies, Inc. ("Applicant") has a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of Arizona pursuant to Decision No. 62021 (November 2, 1999).
- 2. On September 9, 2009, the Applicant filed with the Commission an application for cancellation of the Certificate ("Application").
- 3. On September 23, 2009, the Commission's Utilities Division Staff ("Staff") filed a Staff Report, recommending approval of the Application and cancellation of the Applicant's Certificate without a hearing.
- 4. According to Staff, they contacted Donald Paliwoda, the Applicant's Chief Financial Officer, and confirmed that he is authorized to submit the Application. Staff also verified that the Applicant does not wish to have a hearing in order to cancel the Certificate.

ORDER

IT IS THEREFORE ORDERED that the Application of Phonetel Technologies, Inc. for the cancellation of the Certificate of Convenience and Necessity to provide customer-owned pay telephone service shall be, and is hereby, approved.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
