**BY THE COMMISSION:**

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

**FINDINGS OF FACT**

1. AZMetro Communications, Inc. ("Applicant" or "Company") has a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of Arizona pursuant to Decision No. 59653 (May 15, 1996).

2. On July 18, 2008, the Applicant filed with the Commission an application for cancellation of the Certificate ("Application").

3. On September 22, 2009, the Commission's Utilities Division Staff ("Staff") filed a Staff Report, recommending approval of the Application and cancellation of the Applicant's Certificate without a hearing.

4. According to Staff, on July 17, 2009, Staff contacted Andrew Follmer, part owner of the Company, and verified that Gregg Reichman, also part owner of the Company, is authorized to submit the Application. Staff also verified that the Applicant does not wish to have a hearing in order to cancel the Certificate.





ORDER


