PROCEDURAL ORDER

**BY THE COMMISSION:**

On May 22, 2009, Arizona Public Service Company ("APS") filed with the Arizona Corporation Commission ("Commission") an application for approvals associated with a Power Purchase Agreement ("PPA") to procure renewable energy from a proposed concentrating solar power resource from Starwood Solar I, L.L.C.

On October 6, 2009, APS filed a Motion to withdraw the application ("Motion") because the power resource that was to be developed by Starwood Solar 1, LLC has been terminated.

On October 29, 2009, a Procedural Order was issued requesting that the Commission's Utilities Division ("Staff") file a Response to APS' Motion by November 2, 2009.

On November 2, 2009, Staff filed its Response and indicated that it does not oppose APS' Motion given Starwood's termination of the PPA with APS. Staff recommended that if the Motion is granted, that the Docket be closed.

Accordingly, for good cause shown, APS' Motion should be granted and Docket No. E-01345A-09-0261 should be closed.


