PROCEDURAL ORDER

BY THE COMMISSION:

On September 30, 2008, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against Robert Franklin Hockensmith, Jr. ("Respondent"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts and/or commodity investment contracts.

The Respondent was duly served with a copy of the notice.

On October 10, 2008, a request for hearing was filed by the Respondent, and a hearing was subsequently scheduled to commence on December 1, 2009.

On November 5, 2009, the Division filed a Motion to Vacate the dates scheduled for hearing in the above-captioned proceeding because the Commission had approved a Consent Order at the Open Meeting of the Commission on that date.

Accordingly, the hearing dates should be vacated.




