

Robert L. Prince, being duly sworn, deposes and says:


1. I am a resident of Maricopa County, over 18 years of age, and make this affidavit based on my own personal knowledge.


2. I am the President of Valley Utilities Water Company ("Company").

IMPORTANT NOTICE REGARDING AN INCREASE IN UTILITY RATES

Valley Utilities Water Company (the "Company") filed a request with the Arizona Corporation Commission (ACC) for approval of an arsenic remediation surcharge mechanism ("ARSM"). After hearing and evaluating all the evidence, the ACC authorized a monthly surcharge by meter size as indicated below. The following rates and charges will be effective November 1, 2009. After hearing and evaluating all the evidence, the ACC authorized a monthly surcharge in **Decision No. 71287 (October 7, 2009)** by meter size as indicated below.
