PROCEDURAL ORDER

BY THE COMMISSION:

On June 4, 2009, Coronado Utilities, Inc. ("Coronado" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for a rate increase for wastewater service in the above-captioned docket.

On July 20, 2009, the Residential Utility Consumer Office, ("RUCO"), an entity created by statute to represent residential utility consumers in matter before the Commission filed an Application to Intervene. The Application was granted August 31, 2009.

On October 29, 2009, RUCO filed a Withdrawal of Application to Intervene. No party objected to RUCO's withdrawal.

IT IS THEREFORE ORDERED that RUCO's request to withdraw as an Intervene is granted.


