PROCEDURAL ORDER

BY THE COMMISSION:

On August 12, 2009, Sam Boyles ("Complainant") filed with the Arizona Corporation Commission ("Commission") a formal complaint ("Complaint") against Camp Verde Water System, Inc. ("CVWS" or "Respondent") alleging that Respondent installed a 2-inch meter without Complainant's consent and that Respondent has disconnected water service to the sprinkler system located in Complainant's place of business.

On September 3, 2009, CVWS filed an Answer to the Complaint.

On September 15, 2009, by Procedural Order, a procedural conference was set to commence on October 13, 2009.

On October 13, 2009, the procedural conference was held as scheduled. Complainant appeared. Staff and CVWS appeared through counsel. During the conference, a procedural schedule was discussed, and the parties were directed to engage in settlement discussions.

On November 6, 2009, the parties filed a Joint Notice of Settlement stating all the issues raised in the Complaint had been resolved by the parties. The joint filing also requested withdrawal of the Complaint and administrative closure of the docket.


