APPLICATION OF CIMCO COMMUNICATIONS, INC. AND COMCAST PHONE OF ARIZONA, LLC FOR APPROVAL OF TRANSFER OF CUSTOMER BASE AND FOR CIMCO COMMUNICATIONS, INC. TO DISCONTINUE PROVIDING SERVICE IN ARIZONA

CIMCO Communications, Inc. ("CIMCO") and Comcast Phone of Arizona, LLC ("Comcast Phone") (collectively "Applicants") have filed with the Arizona Corporation Commission ("Commission") a joint application to transfer the assets and the customer base of CIMCO to Comcast Phone. Upon completion of the transfer, Comcast Phone will provide telecommunications services to the existing customers of CIMCO. CIMCO's existing Arizona tariff will be adopted so that CIMCO end users, who will be served by Comcast Phone after the transaction, will continue to receive the same services at the same rates, terms and conditions as at present. All rates, terms and conditions contained in CIMCO customer contracts will be honored by Comcast Phone. Customers of CIMCO will be notified directly of this change in provider by letter mailed no later than 30 days before the anticipated closing date of the transaction. Upon completion of this transaction, CIMCO will discontinue providing service in Arizona and, therefore, seeks to cancel its Certificate of Convenience and Necessity at that time. Commission Rule A.A.C. R14-2-1107(B) provides that interested persons have thirty (30) days from the publication date of this notice to file objections to CIMCO's request to discontinue service and cancel its Certificate of Convenience and Necessity and to request a hearing and/or to submit a motion to intervene in the proceeding. However, failure to intervene will not preclude any interested person or entity from making a statement for the record. If you have any comments, mail them to:
