RESPONSE TO PROPOSED ORDER

12 Verde Santa Fe Wastewater Company ("VSFWC" or "Company") hereby files this
13 Response to Proposed Order in the above-referenced docket.

14 On October 14, 2009, VSFWC filed an application for approval of a revised tariff
15 reducing the commodity rate for effluent sales. On October 29, 2009, Staff filed a request
16 to suspend the time clock to evaluate the Company's tariff filing. On November 4, 2009,
17 Staff filed a proposed order recommending that the Company's tariff filing be suspended
18 for a period of one hundred and twenty days, through March 5, 2010, and that the
19 Company notice its customers of the tariff filing and suspension.

20 VSFWC has no objection to Staff's recommendations. The Company requests that
21 this matter be placed on the Chairman's Consent Agenda, to be taken up at the beginning
22 of the Open Meeting on November 19, 2009.




