NOTIFICATION OF INTERVENTION

BY THE COMMISSION:

On September 8, 2009, the Arizona Corporation Commission ("Commission") issued Decision No. 71274, which approved a rate increase for Sulphur Springs Valley Electric Cooperative, Inc. ("SSVEC" or "Cooperative") and made other findings, including *inter alia*, concerning the planned upgrade and construction of a 69 KV line serving the Elgin/Patagonia/Sonoita area.

On September 28, 2008, SSVEC filed an Application for Rehearing and Reconsideration of Decision No. 71274 pursuant to A.R.S. § 40-253.

At a Special Open Meeting on October 13, 2009, the Commission voted to grant SSVEC's A.R.S. § 40-253 Application for Rehearing and Reconsideration of Commission Decision No. 71274.

On November 5, 2009, Susan Scott, a SSVEC customer filed a Motion to Intervene.

No party objected to the request to intervene.


IT IS THEREFORE ORDERED that Ms. Scott's request to intervene is granted.




