**STAFF MOTION FOR EXTENSION OF
TIME TO FILE AMENDED STAFF
REPORT**


The Arizona Corporation Commission ("Commission"), Utilities Division Staff ("Staff") requests an extension of time to file an amended staff report in this matter. Staff requests an amended staff report due date of one month from the date that Staff receives sufficient documentation from Cup of Gold Water Company, Inc. ("Cup of Gold" or "Company").

At the hearing held on October 28, 2009 the Company was ordered to provide to Staff specific information and supporting documentation so that Staff could properly analyze the Company's application including: (1) Company board meeting minutes authorizing the application in this matter, (2) copies of letters circulated to homeowners regarding the application, (3) amended by-laws of Cup of Gold, and (4) the Homeowners Associations Covenants, Conditions, and Restrictions ("CC&Rs"). Staff was also ordered to file an amended staff report analyzing: (1) whether the amended by-laws reflect Staff's recommendations, (2) whether the CC&Rs reflect the language from the Decision No. 55568 directives, (3) whether the articles of incorporation reflect the language from the Decision No. 55568 directives, (4) the Company's voting structure, and (5) whether a petition is sufficient in lieu of voting.

The Company has not supplied sufficient documentation to Staff to enable Staff to conduct a thorough analysis pursuant to the orders given at the October 28, 2009 hearing. Additionally, the Company has continued to not supply the requested documentation to Staff in a timely manner despite several Staff requests. For example, Staff received a document purporting to be the Homeowners Association's CC&Rs and an incomplete document purporting to be the Company's

1 amended by-laws only yesterday, November 23, 2009. Therefore Staff respectfully requests an
2 extension of time to file the amended staff report in this matter until one month after receiving the
3 required documentation and information from the Company. If this extension is granted, and if so
4 ordered, Staff will file with docket control a notice that Staff has received sufficient documentation to
5 complete an amended staff report that complies with the orders given at the October 28, 2009
6 hearing.
