Staff requests the following clarifications to the Recommended Opinion and Order:

- On page 6, line 13, delete "Paragraph" and insert "Paragraphs" after "Ordering".
- On page 6, move lines 11 through 13 to line 19. Moving this paragraph as modified will clarify the Company's requirement to file tariff pages that reflects both the corrected commodity rates and the surcharge.
