TO DECISION NO. 71329


In Decision 71329, the Commission ordered CVC CLEC, LLC ("CVC") to procure either a performance bond or an irrevocable sight draft letter of credit within 30 days of the effective date of the decision in this matter (which would be November 30, 2009). CVC has been working diligently with its bank to obtain the letter of credit as required by the Decision and Order. The bank recently has addressed several questions about the proper language for the letter of credit with the Commission. CVC did not learn of the bank's difficulties until this week, and now believes the bank has had all of its questions answered. CVC has been advised by the bank that the letter of credit may be issued as early as next week. However, CVC is not certain that this will be done by November 30,

1 2009. CVC will continue to work diligently with its bank to obtain the letter of credit and
2 submit it as soon as it is received.

3 For the reason as set forth above, CVC respectfully requests a 30-day extension of
4 the deadline set forth in Decision No. 71329 to submit a performance bond or an
5 irrevocable sight draft letter of credit.
