Dear Arizona Public Service Company, Commission Utilities Division Staff and Residential Utilities Consumers Office:

On page 43 of the Recommended Opinion and Order ("ROO") there is a reference to Arizona Public Service Company ("APS") Exhibit 37. In order for me to better understand the rate impact of the ROO on a range of residential customers, I would like the three of you to file a joint update to APS Exhibit 37 that incorporates any changes contained in the ROO that may affect the original APS Exhibit 37. In addition, I would like the joint update to include not only the total (i.e., all adjustors, reset of Power Supply Adjustor, etc.) rate impact on the average annual residential customer usage, but also the rate impact on the following:

1. Residential winter median use customer
2. Residential summer median use customer
3. Residential customer using 500 kWh in the winter
4. Residential customer using 500 kWh in the summer
5. Residential customer using 1,000 kWh in the winter
6. Residential customer using 1,000 kWh in the summer
7. Residential customer using 1,500 kWh in the winter
8. Residential customer using 1,500 kWh in the summer
9. Residential customer using 2,000 kWh in the winter
10. Residential customer using 2,000 kWh in the summer

Finally, I would like to know the cost breakout of APS' Advanced Metering Infrastructure ("AMI") program. I understand these costs are embedded within other underlying rate elements and are not explicitly broken out. In order for me to better understand the rate impact of AMI and the status to date of this initiative, I would like the company to detail the amount spent to date, the costs reflected within the rate case itself, future costs anticipated from AMI and all other cost elements related to AMI.

Please docket the above information by 4:00 p.m. on December 3, 2009. If any other party to this docket believes that the information filed in response to this letter is inaccurate or misleading or would just like to comment on the response, that party will be allowed to make such a comment/response at the Open Meeting at which this docket is discussed. Thank you for your cooperation in this matter.
