PROCEDURAL ORDER

12 **BY THE COMMISSION:**

13 On August 3, 2009, Qwest Corporation ("Qwest") filed with the Arizona Corporation  
 14 Commission ("Commission") a Petition for Arbitration of certain terms and conditions for  
 15 interconnection and related arrangements with North County Communications Corporation of  
 16 Arizona ("North County").


17 A telephonic status conference convened on December 4, 2009, at which time Qwest and  
 18 North County confirmed they continued to engage in productive discussions concerning a negotiated  
 19 arbitration agreement. They hope to have a completed agreement by December 15, 2009, which they  
 20 would file with the Commission. If they are unable to reach an agreement, they requested a  
 21 procedural conference in early January to set dates for filing their proposed contract language and  
 22 position statements.

23 IT IS THEREFORE ORDERED that a **telephonic Procedural Conference** for the purpose of  
 24 establishing a schedule for the arbitration of an interconnection agreement, shall commence on  
 25 **January 8, 2010 at 10:00 a.m.**, at the offices of the Commission, Room 218, 400 West Congress,  
 26 Tucson, Arizona. **The number to participate telephonically is 1-866-789-8816 followed by**

2 IT IS FURTHER ORDERED that the Arbitrator may rescind, alter, amend, or waive any  
3 portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


