
**OPPOSITION TO MOTION
TO INTERVENE OF
MR. RICK FERNANDEZ**

8 Global Water – Palo Verde Utilities Company, Global Water – Santa Cruz Water
9 Company, Valencia Water Company – Town Division, Valencia Water Company – Greater
10 Buckeye Division, Water Utility of Greater Tonopah and Willow Valley Water Co. (collectively,
11 the “Global Utilities”) respectfully submit this Opposition to the Motion to Intervene filed by Mr.
12 Rick Fernandez. The Fernandez Motion is untimely. The Commission’s May 28, 2009
13 Procedural Order required all motions to intervene to be filed by October 12, 2009.

14 The Global Utilities are aware that the Commission’s December 4, 2009 Procedural Order
15 granted the late-filed motion to intervene of New World Properties (NWP). However, there are
16 significant differences between the NWP Motion and the Fernandez Motion. The NWP Motion
17 specifically stated that NWP would not: (1) broaden the issues; (2) present any pre-filed
18 testimony; or (3) present any witnesses at the hearing. The Fernandez Motion does not contain
19 these assurances. In addition, the Fernandez Motion was docketed a full week after NWP’s late-
20 filed motion, and nearly two months after the intervention deadline. Accordingly, the Global
21 Utilities request that the Fernandez Motion be denied.
