**APPLICATION FOR LEAVE TO INTERVENE**

The City of Maricopa, a municipal corporation formed under the laws of the State of Arizona ("Maricopa") by and through undersigned counsel, and pursuant to A.A.C. R14-3-105 hereby submits this Motion for Leave to Intervene in the above captioned matter. Maricopa is a City of approximately 45,000 residents who, along with the City itself are customers of the Applicant in this matter and receive their water and sewer service from Global Water Resources.

Maricopa itself along with its residents and business owners will all be directly and substantially impacted by this matter. Maricopa acknowledges that an earlier Procedural Order indicates that the time for intervention has past and that testimony and exhibits have already been filed in this matter. With that in mind Maricopa asks to be permitted to intervene subject to the requirements that it not introduce its own evidence or call its own witnesses in this matter. This limited intervention would be consistent with the Procedural Order granted on December 4, 2009 wherein New World Properties was granted intervenor status.

1 Maricopa does not believe its intervention status will lengthen the proceeding or burden  
2 any of the other intervenors. Maricopa respectfully requests that the Commission enter an Order  
3 granting it intervenor status pursuant to the conditions described herein.


