PROCEDURAL ORDER

BY THE COMMISSION:

On October 24, 1997, U S West Communications, Inc. ("U S West") filed an Application for Expedited Relief From Order ("Application"). On November 6, 1997, AT&T Communications of the Mountain States, Inc. ("AT&T") filed its Response to U S West's Application. On November 24, 1997, U S West filed its Reply. On December 17, 1997, AT&T filed a Motion For Leave to File A Surrebuttal Brief in Opposition to U S West's Application ("Motion") with the Surrebuttal Brief attached. On December 31, 1997, U S West filed its Response to AT&T's Motion. U S West opposed AT&T's Motion, stating that there is no need for presentation of additional arguments at this stage of the proceeding, but requested leave to file a Reply if AT&T's Motion were granted.




