PROCEDURAL ORDER

BY THE COMMISSION:

On August 29, 1997, the Arizona Corporation Commission ("Commission") issued Decision No. 60353, determining the issues of combinations of network elements. Decision No. 60353 ordered AT&T Communications of the Mountain States, Inc. ("AT&T") and U S WEST Communications, Inc. ("U S WEST") to incorporate within their interconnection agreement the approved language within thirty days from the date of Decision No. 60353, and file confirmation of such incorporation with the Commission.

On September 29, 1997, U S WEST filed a Notice of Amendment to Interconnection Agreement between itself and AT&T. The Amendment incorporates the language included in Decision No. 60353, and therefore is in compliance with the Decision.

IT IS THEREFORE ORDERED that the First Amendment dated September 25, 1997 to the Agreement for Local Wireline Interconnection and Local Service Resale between U S WEST Communications, Inc. and AT&T Communications of the Mountain States, Inc., executed on September 26, 1997, is in compliance with Decision No. 60353.

IT IS FURTHER ORDERED that the Amended Agreement shall become effective immediately.


