**BY THE COMMISSION:**


On October 24, 1997, U S West Communications, Inc. ("U S West") filed an Application for Expedited Relief From Order ("Application"). On November 6, 1997, AT&T Communications of the Mountain States, Inc. ("AT&T") filed its Response to U S West's Application. On November 24, 1997, U S West filed its Reply. On December 17, 1997, AT&T filed a Motion For Leave to File A Surrebuttal Brief in Opposition to U S West's Application ("Motion") with the Surrebuttal Brief attached. On December 31, 1997, U S West filed its Response to AT&T's Motion. By Procedural Order issued on February 26, 1998, AT&T's Motion was granted and U S West was given the opportunity to file a Response to the Surrebuttal Brief filed on December 17, 1997. On March 13, 1998, U S WEST filed its Response. Accordingly, oral arguments on the Application will be heard on June 3, 1998 at the Commission's offices in Phoenix, Arizona.


