PROCEDURAL ORDER

BY THE COMMISSION:

By Procedural Order dated July 15, 2009, this matter was set for hearing and a procedural schedule established.

On December 14, 2009, the Arizona Corporation Commission's ("Commission") Utilities Division ("Staff") filed a Motion to Extend Time. Staff requests an extension of time to file to its Direct Testimony on Revenue Requirement/Rate Base from December 15, 2009, to December 23, 2009. Staff indicates that the applicant does not oppose the request.

The request is relatively short and Staff will be filing Cost of Capital Testimony on December 15, 2009. Under the circumstances, the request is reasonable.

IT IS THEREFORE ORDERED that the deadline for filing Direct Testimony related to Revenue Requirement for all parties is extended until December 23, 2009.
