BY THE COMMISSION:

FINDINGS OF FACT

1. On October 14, 2009, Verde Santa Fe Wastewater Co., Inc. filed an application for approval of a revised tariff reducing the commodity rate for effluent sales.

2. The Company proposes to reduce the rate for effluent sales from \$2.00 per one thousand (1,000) gallons to \$.40 per one thousand (1,000) gallons.

3. Staff has not had adequate time to review the application to determine whether or not the proposed tariff revision is revenue neutral. While Staff does not believe that this application is the type of tariff filing subject to the 30-day time clock, in an abundance of caution, Staff recommends that the filing be suspended for a period of one hundred twenty days through and including March 5, 2010.

4. The Company should notice its customers of its tariff filing and this suspension.

CONCLUSIONS OF LAW

1. Verde Santa Fe Wastewater Co., Inc. is an Arizona public service corporation within the meaning of Article XV, Section 2 of the Arizona Constitution.
2. The Commission has jurisdiction over Verde Santa Fe Wastewater Co., Inc. and over the subject matter of the application.
3. The Commission having reviewed the application and Staff's Memorandum dated November 4, 2009, concludes that it is in the public interest to suspend the filing for a period of one hundred twenty (120) days.

ORDER


IT IS THEREFORE ORDERED the filing be and hereby is suspended for a period of one hundred twenty (120) days, up to and including March 10, 2010.




IT IS FURTHER ORDERED that this Decision shall become effective immediately.


