BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. Telaleasing Enterprises, Inc. ("Applicant") has a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of Arizona pursuant to Decision No. 59888 (November 26, 1996).
2. On September 3, 2009, the Applicant filed with the Commission an application for cancellation of the Certificate ("Application").
3. On October 26, 2009, the Commission's Utilities Division Staff ("Staff") filed a Staff Report, recommending approval of the Application and cancellation of the Applicant's Certificate without a hearing.
4. According to the Staff Report, the Applicant stated in its Application that it no longer provides COPT service in Arizona and wishes to waive its right to a hearing.
5. Staff stated that the Consumer Services Section of the Utilities Division reported that

1 from January 1, 2006, through September 18, 2009, there were no consumer complaints, inquiries, or
2 opinions filed against the Applicant.

3 6. Staff notes that the Applicant is not in good standing with the Commission's
4 Corporations Division for failure to file an Annual Report due May 17, 2009.

5 7. Staff's recommendation is reasonable and should be adopted.

6 **CONCLUSIONS OF LAW**

7 1. The Applicant is a public service corporation within the meaning of Article XV of the
8 Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

9 2. The Commission has jurisdiction over the Applicant and the subject matter of the
10 Application.

11 3. The cancellation of the Applicant's Certificate is in the public interest.

12 4. Pursuant to A.R.S. § 40-282, the Commission may issue Decisions regarding COPT
13 Certificates without a hearing.

14 5. Staff's recommendation is reasonable and should be adopted.




ORDER


