# BOND FOR UTILITY USERS

BOND NO.                     

KNOW ALL MEN BY THESE PRESENTS: That we, YMAX COMMUNICATIONS CORP., as Principal, and GREAT AMERICAN INSURANCE COMPANY, as Surety, are jointly and severally bound unto the users of Principal in the sum of ONE HUNDRED TEN THOUSAND AND NO/100 Dollars (\$ 110,000.00), lawful money of the United States of America, to be paid as hereinafter provided for which payment will and truly to be made, we bind ourselves, and each of our successors and assigns, jointly and severally by these presents.

THE CONDITIONS OF THIS OBLIGATION ARE THAT: Whereas, the above bounden Principal has contracted with the users of the Principal for the furnishing of competitive retail telecommunications service.

NOW THEREFORE, if the said Principal, or any assigns of his falls to provide competitive retail telecommunications services so furnished, the said Surety will pay the same to the users of the Principal with the consent of the Arizona Corporation Commission as Trustee, an amount not exceeding the sum hereinabove specified.

THE BOND SHALL REMAIN IN FULL FORCE and effect until cancelled by mutual agreement of the Arizona Corporation Commission, the Principal and the Surety. The Surety's liability shall be terminated and bond cancelled upon written notice of the cancellation by the Surety to the Principal with a copy of the Arizona Corporation Commission no less than thirty days prior to the cancellation date. Notice to the Principal shall be by certified mail in a sealed envelope with the postage prepaid. Proof of notice to the Principal shall be made available to the Arizona Corporation Commission upon request.
