**PROCEDURAL ORDER**  
**CORRECTING CLERICAL ERROR**  
**IN DECISION NO. 71446**  
**NUNC PRO TUNC**

BY THE COMMISSION:

On December 23, 2009, the Arizona Corporation Commission ("Commission") issued Decision No. 71446, which granted a rate increase to Utility Systems, LLC, d/b/a Gardner Water Company and a rate increase to Utility Systems, LLC, d/b/a Christopher Creek Haven Water Company (collectively, the "Company").

Finding of Fact No. 223 in Decision No. 71446 states, among other things, that the Commission adopts Staff's recommended rates and charges, except that the Company shall be permitted to charge a Late Fee of \$5.00. This Late Fee charge was not correctly reflected in the Ordering Paragraph delineating the Company's rates and charges, on page 41, line 23 of the Decision.

Accordingly, the clerical error found on page 41, line 23, of Decision No. 71446, should be corrected *Nunc Pro Tunc*.

IT IS THEREFORE ORDERED that the statement, "Late Charge—Per Month 1.5%," found on page 41, line 23, in Decision No. 71446, is hereby corrected *Nunc Pro Tunc* to read, "Late Charge—Per Month \$5.00."




