

Motion to Demand Information Required for Defense

I again demand the Arizona Corporation Commission provide the information I must have to subpoena witnesses that are essential to my defense and to revealing the truth in this matter of attempted extortion, abuse of power and malicious prosecution. I demand the court to do its job as required by law and force them to give the information requested that is essential for the truth and justice! What law allows you to block information I need for a defense? This behavior is illegal and immoral! I demand the information immediately!

This is the fifth time I have had to ask the court to provide basic information that by law I have a right to! I demand the AZ Corporation be forced to provide all the contact information for Peggy Scozzari. Peggy Scozzari is listed as the person that misrepresented themselves as an accredited investor and lied to get proprietary and confidential business property that the AZ Corporation Commission abused in their malicious prosecution for the purpose of extortion of the defendant/respondent.

I also demand the AZ Corporation be forced to provide all the contact information for the court reporter who is a witness to the attempted extortion and threats by Wendy L. Coy. This court reporter was present on 2-26-2009. I must have her contact information and the court must subpoena her and compel her to testify under oath.

Further, the associate of Wendy L. Coy and employee of Securities division that always accompanies Wendy L. Coy to all hearings must be revealed to me, subpoenaed and compelled to testify under oath. This is the third time I have asked for this and still they refuse. This is an outrage to justice that the Securities division is allowed to deny me basic essential information I am legally entitled to! I demand action. I demand the information be provided for all three of these people, and I demand the most severe sanctions possible be assessed against these immoral devious people!!!!!! They make a mockery of our legal system.

The ability to contact, interview and compel Peggy Scozzari and these two other people (whose names have been blocked from me) to testify under oath under cross examination is absolutely essential to any defense. The Arizona Corporation Commission Securities Division has intentionally blocked out and refused multiple requests for this person's information in order to deny me a fair trial.

I demand the court subpoena all these people and compel them to attend the hearing and testify under oath: Witnesses to be subpoenaed by the court and compelled to testify under oath:

7. *the court reporter referred to in this case who worked on 2-26-2009*
