PROCEDURAL ORDER

BY THE COMMISSION:

12 On September 18, 2006, Zeus Telecommunications, LLC ("Applicant" or "Zeus") submitted
 13 to the Arizona Corporation Commission ("Commission") an application for a Certificate of
 14 Convenience and Necessity ("Certificate") to provide resold long distance telecommunications
 15 services within the State of Arizona.

16 On January 3, 2007, the Commission's Utilities Division Staff ("Staff") filed a Letter of
 17 Insufficiency and its First Set of Data Requests in this docket.

18 On June 16, 2008, by Procedural Order, Staff was ordered to file an update, along with
 19 appropriate recommendations, on Zeus' application due to the fact that as of that date Applicant had
 20 neither responded to Staff's Data Requests nor made any other filings in this matter.

21 On August 12, 2008, Staff filed a memorandum updating the Commission of the status of
 22 Zeus' application and stated that based on the information Staff had received from the Applicant,
 23 Staff believes this docket should remain open.


24 To date, no other filings have been made in this docket. Accordingly, Staff should make a
 25 filing updating the Commission on the status of this application.

26 **IT IS THEREFORE ORDERED that Staff shall file an update on Zeus' application**
 27 **along with any appropriate recommendations no later than February 15, 2010.**
