### APPLICATION FOR LEAVE TO INTERVENE

Cyprus Climax Metals Company, ASARCO Incorporated, Enron Corp. and Arizonans for Electric Choice and Competition (collectively referred to herein as "AECC") hereby request leave to intervene in the above-captioned proceeding.

AECC will be directly and substantially affected by the proceedings in this docket because the actions taken by the Commission with respect to the Unbundled Service Tariffs filed by Tucson Electric Power Company will have a significant impact on competition in the generation of electric power in the State of Arizona and on the rates and charges AECC will have to pay for the services covered by the proposed tariffs. AECC has been granted leave to intervene in the stranded cost proceedings that have taken place to date and in Tucson Electric Power Company's Application for Approval of Its Plan for Stranded Cost Recovery. The granting of AECC's application for leave to intervene in this proceeding will not cause the issues to be unduly broadened, except upon leave of the Commission.
