Dear Sir or Madam:

On April 24, 2006, Qwest filed tariff changes which implemented various provisions of Qwest's renewed price cap plan as approved in Decision No. 68604. As part of that filing, Basket 2 and 3 services that were previously included in the Exchange and Network Services Tariff were moved to the Competitive Exchange and Network Services Tariff. The attached tariff pages for the SMARTSET Feature Packages were removed from the Exchange and Network Services Tariff, but were inadvertently omitted from the Competitive Tariff. Notwithstanding this omission, these packages continue to be available to customers under the terms and conditions and at the rates prevailing prior to Decision No. 68604.

Qwest respectfully submits these pages and requests that they be processed as an amendment to the Company's April 24, 2006, compliance filing. Consistent with that filing and Decision No. 68604, these pages reflect an effective date of May 1, 2006. Use of this effective date will ensure a continuous tariff "history" for these packages.

- Call Forwarding Busy Line/Don't Answer Expanded
- Message Waiting Indication Audible

2. Terms and Conditions

- a. The rates and charges are in addition to all rates and charges for the associated underlying service.
- b. All terms and conditions specified elsewhere for the respective services/features shall apply.
- c. Nonrecurring charges do not apply to change an existing Custom Calling Package to either the *SMARTSET* or *SMARTSET PLUS* Package.
