PROCEDURAL ORDER

BY THE COMMISSION:

On July 2, 2009, Arizona-American Water Company ("Arizona-American" or "Company") filed with the Arizona Corporation Commission ("Commission") an application for rate increases for its Anthem Water District, Sun City Water District, Anthem/Agua Fria Wastewater District, Sun City Wastewater District, and Sun City West Wastewater District.

A hearing date and associated procedural deadlines were set in a Rate Case Procedural Order issued on September 24, 2009.

Intervention in this matter has been granted to the Residential Utility Consumer Office, Anthem Community Council, and the Sun City West Property Owners and Residents Association.

On January 8, 2010, W.R. Hansen filed a Motion to Intervene. No opposition has been filed,

1 and the Motion to Intervene should therefore be granted.

2 On January 25, 2010, the Commission's Utilities Division ("Staff") filed a Motion for
3 Extension, requesting an extension of time to March 22, 2010 to file its rate design testimony, which
4 is currently due to be filed by Staff and intervenors on March 8, 2010. The Motion for Extension
5 indicated that the Company has agreed to Staff's proposed extension of time.

6 Staff's request is reasonable and should be granted. The deadline for the Company to respond
7 to rate design testimony should also be extended.

8 IT IS THEREFORE ORDERED that W. R. Hansen is hereby granted intervention.

9 IT IS FURTHER ORDERED that any testimony and associated exhibits to be presented at
10 hearing on behalf of Staff and intervenors on rate design issues shall be reduced to writing and filed on
11 or before **March 22, 2010**.

12 IT IS FURTHER ORDERED that any rebuttal testimony and associated exhibits to be
13 presented at hearing by Arizona-American on the issue of rate design shall be reduced to writing and
14 filed on or before **April 5, 2010**.

15 IT IS FURTHER ORDERED that all other filing deadlines set forth in the September 24,
16 2009 Rate Case Procedural Order shall remain unchanged.

17 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
18 Communications) continues to apply to this proceeding and shall remain in effect until the
19 Commission's Decision in this matter is final and non-appealable.

20 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend,
21 or waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
22 hearing.
