

APPLICATION OF THE WATER UTILITIES ASSOCIATION OF ARIZONA TO INTERVENE

Pursuant to A.A.C. R14-3-105, The Water Utility Association of Arizona

1 (WUAA) hereby moves the Commission for leave to intervene in the above-captioned
2 proceeding. The Water Utility Association of Arizona is a non-profit corporation representing the
3 investor-owned segment of the water industry in the state of Arizona. The association has a
4 regular membership of approximately 100 investor-owned water companies, serving from 1 to
5 400,000 customers.

6 The purpose of the Association is to promote regulatory policies that will: promote
7 investment, encourage conservation and protect consumers in order to ensure that Arizona has
8 adequate supplies of safe, affordable water—as well as the infrastructure required to deliver that
9 water to consumers at affordable prices.

10 Arizona American Water is a member of the Water Utilities Association of Arizona
11 additionally, several of the policy issues addressed in the Arizona American Application have
12 broad implications for the private water industry.

13 However, the granting of intervenor status to the WUAA will not unduly delay the
14 proceedings or cause the issues to be unduly broadened. The WUAA requests that all


20 For the reasons discussed above, the WUAA respectfully requests that it be granted leave
