**REQUEST TO CLOSE DOCKET**

On December 10, 2008, on the advice of Staff, the Company filed a request for an emergency rate increase to pay for the extraordinary costs of paying the city of Prescott to provide water supplies to its customers. Those costs are not being recovered in the current rates provided for by the Commission. The Company has not yet installed the arsenic treatment system required to supply water meeting federal health standards from the Company's wells. When that system is installed, the Company will disconnect from the City of Prescott and the extraordinary costs the Company currently pays will cease.

Until that time, it is impossible to calculate an appropriate rate or mechanism to recover the additional costs.

The Company requests that its application for an emergency rate increase be withdrawn at this time.
