11 Arizona Corporation Commission ("Commission") in this docket on January 25, 2010.


12 Qwest's Voice Mail Service was deregulated by order of the Commission in Decision
13 Number 68604, Docket Number T-01051B-03-0454, commonly referred to as Qwest's
14 Renewed Price Cap Plan. See, page 11, lines 8-14, Decision Number 68604, and Section 21
15 of the Settlement Agreement which is attached to the Decision.

16 Because it has been deregulated, Qwest's Voice Messaging Service is no longer
17 tariffed and is now included in Section 10.12 of the Company's Exchange and Network
18 Services Catalog, which provides information pertaining to deregulated services.

19 Qwest suggests that Docket T-01051B-98-0575 should be closed.
