15 The Residential Utility Consumer Office ("RUCO") hereby requests until January 7,  
16 2010 to respond to LPSCO's Motion to Strike. RUCO's request is based on the  
17 following. LPSCO's Motion was received by RUCO electronically on December 22,  
18 2009. The attorney assigned to the case, Michelle Wood has been out of the state and will  
19 continue to be out of the state until January 4, 2010. The undersigned was also out of the  
20 office since December 21, 2009 and only returned today, December 28, 2009. In addition to  
21 Ms. Wood, RUCO's Chief analyst, William Rigsby, is also out of the office, and unavailable  
22 all of this week. The undersigned is not familiar with the particulars of the motion and could  
23 make some argument which, at best, would be very limited.

24 It would be in RUCO's best interests, as well as far more informative for the  
Commission, to allow RUCO to have the principals involved in the case the opportunity to  
respond. Therefore, RUCO requests another five business days (not counting holidays) to  
respond to LPSCO's Motion to Strike.


