RE: Application to Add a New Maximum Rate on the Qwest 5 Cent Plan for residential customers on behalf of Qwest LD Corp., T-04190A

Dear Sir or Madam:

Pursuant to R14-2-1110, Qwest LD Corp. hereby submits this application to add a new maximum tariffed rate for a competitive telecommunications service. Qwest applies to add a new maximum monthly charge of \$10.00 on a per account basis for the residential calling plan identified below. Qwest proposes that the actual charge billed to its customers will be \$1.99 if the addition of the maximum charge is approved by the Arizona Corporation Commission. This plan has an existing monthly charge on a per line basis and this new charge is in addition to this existing charge. As grounds therefore, Qwest states as follows:

Reasons for Rate Increase

The new rate requested by Qwest is just and reasonable. In a competitive market, such as the residential direct dialed long distance market, if a customer does not agree that the rate charged is fair and reasonable, that customer can choose a new provider.

Customer Notification

Qwest is properly notifying its customers of the proposed increase consistent with the Commission's requirements. See notice and affidavit of mailing attached as Exhibit 1.

Schedule of Current and Proposed Rates

The table below sets out the current and proposed maximum rates.

Estimated Revenues

The additional estimated potential interstate annual revenue to be derived from the proposed increase is shown in Confidential Exhibit 2.

Proposed Effective Date

The proposed effective date for this change is February 15, 2010. This change will only go into effect upon approval from the Commission.

Other States

Qwest LD Corp. provides these same calling plans in New Mexico, Colorado, Wyoming, Idaho, Montana, Utah, Oregon, Washington, Iowa, Minnesota, Nebraska, North Dakota, and South Dakota. The interstate monthly rate per account of \$1.99 went into effect on February 15, 2010.

Attached as Exhibit 3 to this application are the tariff pages, an original and thirteen (13) copies to Qwest LD Corp.'s ("QLDC") Tariff No.2.

3.2 CALLING PLANS (Cont'd)

3.2.29 5 CENT PLAN

A. Description

The 5 Cent Plan will allow a residential customer to complete direct dialed calls between any two points within the state.

B. Terms and Conditions

1. This plan is provisioned in conjunction with the interstate 5 Cent Plan that has a monthly recurring fee. A monthly recurring charge set forth below will apply for this intrastate plan. This charge is identical to, and shall not be in addition to, any monthly recurring charge applicable to the corollary interstate 5 Cent Plan for long distance calling.
2. The 5 Cent Plan is only available on an intrastate basis when the customer has subscribed to the interstate 5 Cent Plan for residential customers.
3. Calls made using the 5 Cent Plan are billed in full minute increments.
4. The 5 Cent Plan is only available to customers subscribing to retail local service from Qwest Corporation.
5. The Company may offer free calls between any two points within the state during nights and weekends for residential customers and is provided in conjunction with qualifying Qwest Wireless services. Weeknights: Monday – Friday, 7:00p.m. - 7:00a.m. Weekends: Saturday – Sunday, Day: 7:00a.m. - 7:00p.m.; Night: 7:00p.m. - 7:00a.m.


