PROCEDURAL ORDER

1 **BY THE COMMISSION:**

2 On March 9, 2009, Litchfield Park Service Company ("LPSCO") filed with the Arizona
3 Corporation Commission ("Commission") applications for rate increases for wastewater and water
4 service in above-captioned dockets SW-01428A-09-0103 and W-01427A-09-0104 ("Rate Dockets").
5 By Procedural Order issued May 21, 2009, the Rate Dockets were consolidated.

6 On March 13, 2009, LPSCO filed financing applications in Docket Nos. W-01427A-09-0116
7 and W-01427A-09-0120. By Procedural Order issued November 6, 2009, Docket Nos. W-01427A-
8 09-0116 and W-01427A-09-0120 ("Finance Dockets") were consolidated.

9 The evidentiary hearing in the above captioned matter commenced on January 4, 2010 and
10 concluded on January 15, 2010.

11 During a January 13, 2010 Staff Meeting, the Commission voted to conduct a public comment
12 meeting in LPSCO's service area on a date to be determined.

13 **IT IS THEREFORE ORDERED that the Commission will hold a public comment meeting**


