On February 15, 2008, Del Rio Water Company, LLC ("Del Rio" or "Company") filed with the Arizona Corporation Commission ("ACC" or "Commission") an application for a Certificate of Convenience and Necessity ("CC&N") to provide water service in Yavapai County, Arizona.

On July 28, 2008, a hearing on the merits of the case was held. Based on the testimony and evidence presented and the docketed filings, it was determined that additional information was needed and that the matter should be set for an additional day of hearing.

On August 8, 2008, by Procedural Order, this matter was set to reconvene on November 14, 2008; filing deadlines were established; and the time clock was suspended.

On August 21, 2008, Staff issued Data Requests in an effort to gather additional information. Del Rio failed to provide responses to the data requests Staff issued and Del Rio requested a series of postponements.

On November 5, 2009, a Procedural Conference was held. The Administrative Law Judge ("ALJ") after reviewing the pleadings that had been filed and listening to the oral arguments, granted Del Rio's request for an extension of time to process its application in this docket until December 31, 2009. The ALJ noted that, if nothing concrete is filed in this docket regarding financing by December 31, 2009, she will be writing a Recommended Opinion and Order to the Commission recommending that this docket be closed.

On December 31, 2009, Del Rio filed a Notice of Withdrawal of Application.
