 13 the Commission's disposition of Docket No. E-01345A-09-0338, Arizona Public Service Company's
 14 Application for Approval of its Renewable Energy Standard and Tariff Implementation Plan for
 15 2010. Unfortunately, the text of Decision No. 71459 does not contain a number of amendments that
 16 were adopted by the Commission at the December 22, 2009 open meeting. These omissions were not
 17 intentional, and were merely the result of clerical errors.
